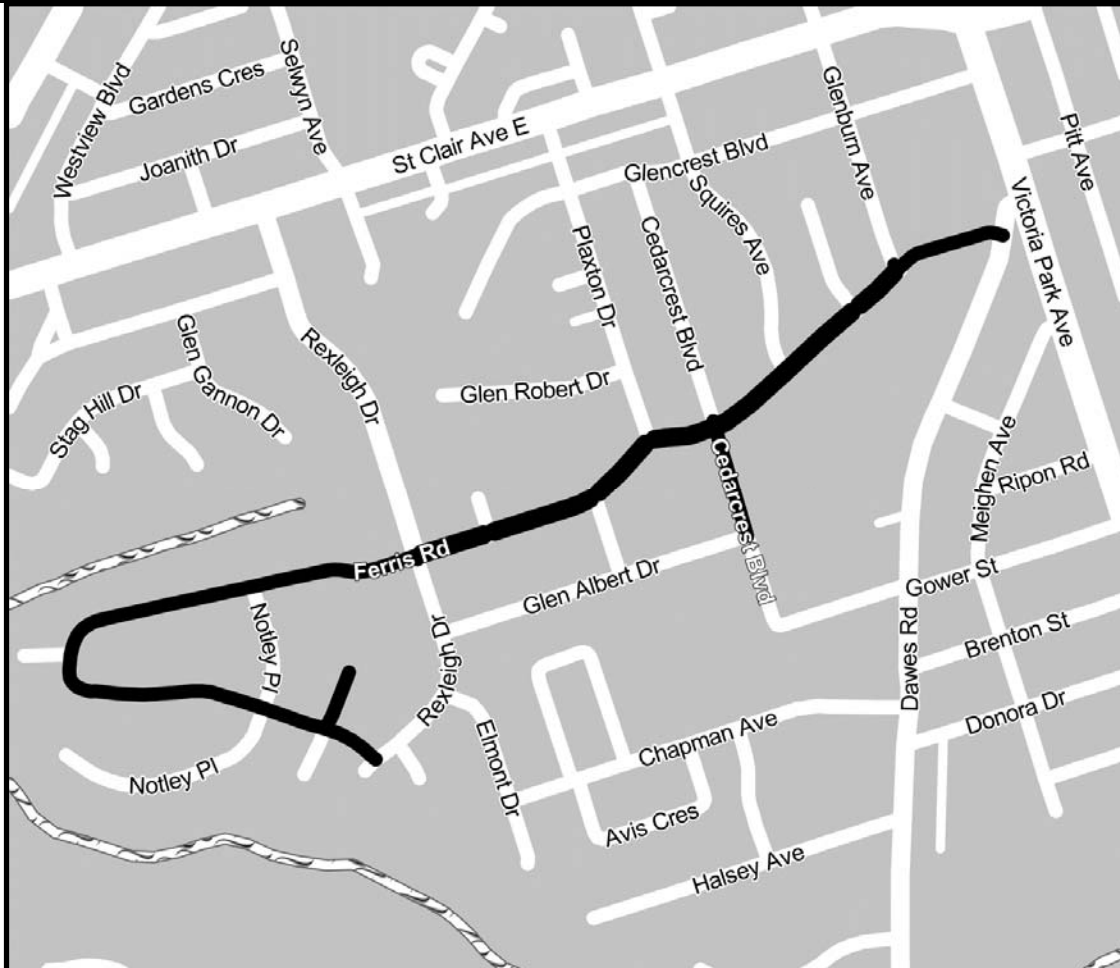

As you know the City has been replacing the watermain and substandard water services in your area. This project was supposed to be completed by June 30, because additional restoration work is needed, the project will now be finished at the end of July.

Restoration activities have started, as a result, there will be ongoing local lane closures along Ferris Road between the south end of Rexleigh Drive to Dawes Road.

We recognize that a project of this nature is disruptive to the community and appreciate your patience.

WORK UPDATE

To date the contractor has:

- Installed the new watermain
- Replaced substandard water services






Restoration work involves:

- Replacing sidewalk, driveways and curb affected by work
- Replacing sod affected by work
- Restoring the road

The restoration should be completed by the end of July 2016.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences while restoration work continues.

	<p>Work Hours: Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work area.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times. Access for emergency vehicles will be maintained at all times.</p> <p>Accommodation: Residents that require accommodation must contact the Field Ambassador to arrange for access during the construction period.</p>
	<p>Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. Please contact parking control for the location of your vehicle at 416-808-2222.</p> <p><i>In the event you receive a traffic ticket for on-street parking during this period of construction, please immediately contact the Field Ambassador listed below, so that your tickets can be cancelled.</i></p> <p>Please note that parking tickets cannot be cancelled if vehicles have parked in illegal parking spots such as hydrant violations or no parking zones or if they are submitted to the Construction Inspector later than three days of receipt.</p>
	<p>Garbage & Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <i>Please ensure that you label your bins with your address.</i></p>
	<p>TTC Service: This project may affect travel times on the 23 Dawes Road bus route. Visit ttc.ca for accurate schedule information.</p>
