## Sanitary Trunk Sewer Rehabilitation From Echo Valley Park to the Islington Golf Course

**Expected Start Date: Summer 2017**

**Expected End Date: Fall 2018**



The City of Toronto is planning to rehabilitate the North and the South Mimico sanitary trunk sewers (STS) from Echo Valley Park, near Wingrove Hill and Kipling Avenue, to the Islington Golf Course (see map). The two trunk sewers are located close to the Mimico Creek and cross the Creek a few times.

The sanitary trunk sewer is an underground pipe that collects wastewater from sewers and delivers it to wastewater facilities for treatment.

Toronto Water has prioritized this repair work due to corrosion and other defects in the sewers. This project is part of the Council-Approved 2017 Capital Works Program to renew the City's aging sewer infrastructure and will extend the service life of these trunk sewer sections by approximately 50 years.

### WORK DETAILS

Along with the trunk sewers a local sanitary sewer in Islington Golf Club from 61A Bywood Drive to South Mimico STS will also be rehabilitated. This will be accessed from Remington Drive cul-de-sac and completed in few weeks with the trunk sewers rehabilitation during winter 2018.

The City's contractor will move equipment on-site and prepare the work area before construction begins. Majority of the work is taking place in the Echo Valley Park or in areas owned by Islington Golf Club in phases. Work in the park will take place in the Summer of 2017, work on the golf course will occur in the winter of 2018.

- The sewers will be relined using a trenchless method. A sock filled with resin will be inserted into the pipe through the sewer maintenance hole and is cured in place with steam for 8-10 hours. When cured a new pipe is formed within the existing pipe.
- Restoration work will occur in Spring/Summer-2018

## WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark underground utilities, such as gas, water and cable to ensure they are not affected by the work.
- A Construction Notice will be distributed approximately two weeks before work begins with more details about the work.

	<p><b>Accessible Accommodation:</b> Residents who require accommodation (level entry, longer notice, etc.) must contact the <b>Project Manager</b> to arrange for access during the construction period.</p>
	<p><b>Tree Removals:</b> Due to the nature of this project, the City's contractor will have to remove up to 61 City-owned trees in the Park to facilitate construction work and to create the needed accesses to the sewer maintenance holes. Efforts have been made to ensure as few trees as possible are removed.</p> <p>A restoration plan approved by the City's Parks Forestry &amp; Recreation Services and the Toronto and Region Conservation Authority will be implemented which includes planting up to 215 trees and 94 shrubs and seeding/naturalizing the area when construction is complete.</p>
	<p><b>Park / Trail Access:</b> For public safety and to separate the construction work from park and path users; a portion of the Echo Valley Park and Mimico Trail from Wingrove Hill to Echo Valley Road will be temporarily closed between for the duration of the project. Detour and Closure signage will be installed to help trail users.</p>
