## Watermain Replacement on Shorncliffe Road and other local roads, Road Reconstruction and Resurfacing on Shorncliffe Road

Contract 17ECS-TI-104LR

Start Date: May 23, 2017

End Date: October 31, 2017

*\*Timeline is subject to change.*

The City of Toronto is replacing the watermain and the City-owned portion of substandard water services on Shorncliffe Road (from North Queen Street to 230m north of Lockport Avenue), Lockport Avenue and Newbridge Road (see map below). The City of Toronto will install portions of new sidewalk and resurface / reconstruct Shorncliffe Road from North Queen Street to Dundas Street West when the watermain work is complete.

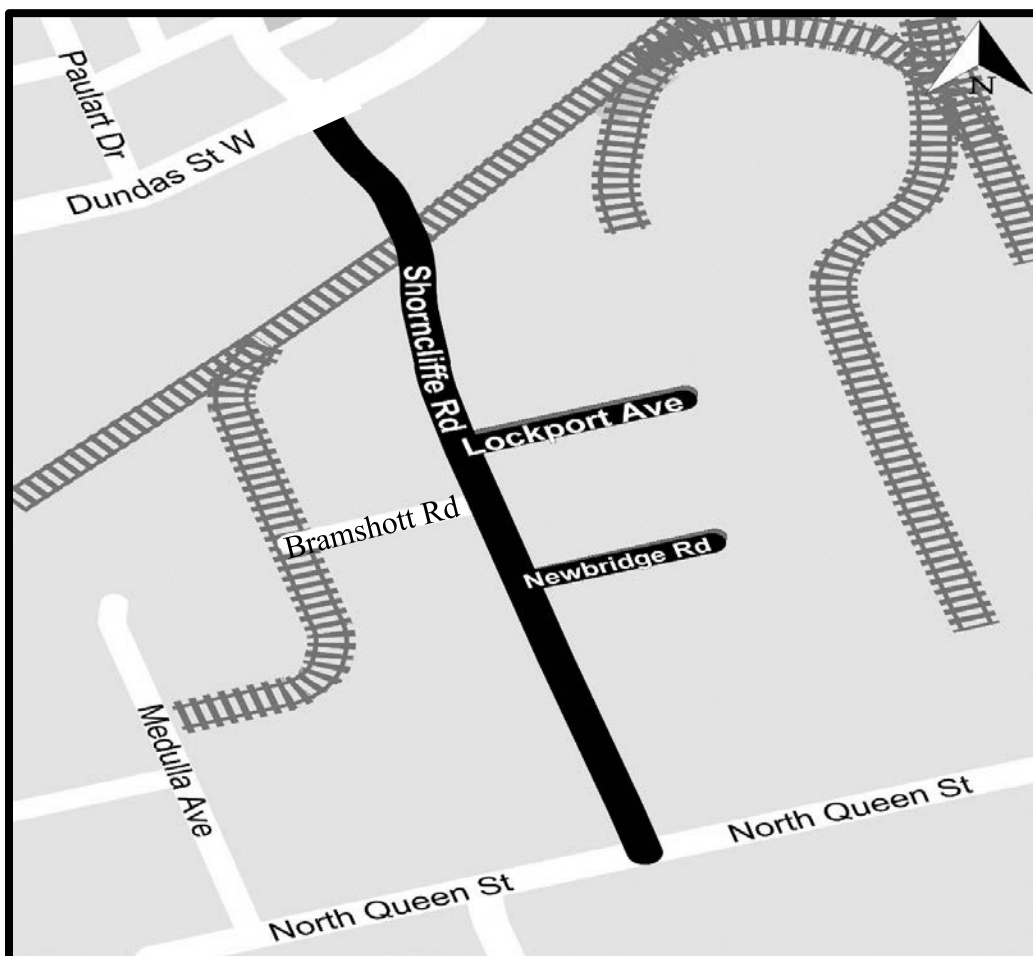
The water service is the underground pipe that brings water to your property and is owned by you and by the City. The part you own is from your house/building to the end of your property, the part the City owns is from the end of your property to the watermain.

This work is needed to bring the watermain to a state of good repair. This project is part of the Council-approved 2017 Capital Works Program to renew aging infrastructure and improve water service delivery by preventing watermain breaks for current and future needs.

### IMPORTANT INFORMATION ABOUT LEAD WATER SERVICES

If you live or have a business on the streets highlighted in the map below in a residence/building that was built before the mid-1950s, your water service may be made of lead. Please read the attached fact sheet with important information about the risks of lead in drinking water, especially if someone in your house/building is pregnant, there are children under six years old, or there is an infant drinking formula made using tap water.

## WORK DETAILS







The City's contractor will:

- Replace any City-owned water service pipes that do not meet City standards from the watermain to the private property line
- Construct sidewalk on the west side of Shorncliffe Road from Bramshott Road to North Queen Street
- Resurface the road with new asphalt on Shorncliffe Road from North Queen Street to Bramshott Road
- Reconstruct the road on Shorncliffe Road from Bramshott Road to Dundas Street with new road base and new asphalt road surface.
- Restore the project area to match or exceed the existing conditions (Lockport Avenue and Newbridge Road)

## WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- Work in the boulevard in front of homes is expected. This work includes removing and replacing driveways, municipal sidewalks and boulevards, where necessary.
- Property owners should remove items located within City property limits (boulevard), such as landscaping, fencing, irrigation systems, and / or decorative objects.
- The City will not be responsible for damage to any privately owned items on City property.

	<p><b>Work Hours:</b> Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p><b>Pre-Construction Inspection:</b> OZA Inspections Ltd. under contract to the City of Toronto, will survey all properties within 30 metres of the construction area before construction starts. Participation in the survey is voluntary; however, participating is important in determining if the construction caused damage. The inspection will look at both the interior and exterior of all properties to verify existing conditions. The company will deliver a separate notice requesting time to set up appointments. All inspection staff will be wearing photo identification and carrying photographic equipment during their work.</p>
	<p><b>Water Service Disruptions:</b> From time-to-time, the water supply to your property may be shut-off to complete construction; the contractor will provide at least 24-hour advance notice. Throughout the work, it is recommended that you temporarily disconnect any water treatment systems (i.e. softeners or filters), water-cooled air conditioners or similar plumbing fixtures. Automatic lawn sprinkler systems may also be affected, therefore, you may need to water manually. In rare instances an <b>emergency water shut off</b> may occur without notice.</p>
	<p><b>Substandard Water Service Replacement:</b> Please take the time to read the attached fact sheet carefully as it contains important information on lead in drinking water and how to prepare for replacement. If you want to replace your part of the water service pipe, the City recommends you get <b>three quotes</b>. You can contact the City's contractor for one of your quotes.</p>

	<p><b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p><b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p><b>Traffic Management:</b> Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.</p> <p><b>TRAFFIC WILL BE RESTRICTED TO ONE LANE IN EACH DIRECTION ON SHORNCLIFFE ROAD AS REQUIRED AND TO ONE LANE AT TIMES ON LOCKPORT AND NEWBRIDGE AS REQUIRED.</b></p>
	<p><b>Parking:</b> Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at <b>416-808-2222</b>.</p>
	<p><b>TTC Service:</b> This project may affect travel times on the 123 Shorncliffe Road bus. Bus stops will be relocated to a nearby location, as required.</p> <p><b>Visit <a href="http://ttc.ca">ttc.ca</a> for accurate schedule information.</b></p>
	<p><b>Garbage &amp; Recycling:</b> Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them.</p> <p><b>Please ensure that you label your bins with your address.</b></p>
	<p><b>Restoration:</b> The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced.</p>
