Storm Sewer Replacement and Road Resurfacing on Weston Rd from Jane Street to Lawrence Ave West

Contract: 17ECS-TI-02MR
Start Date: August 8, 2017
End Date: September 30, 2017

The City of Toronto will complete the following work on Weston Road:

- replace the storm sewer and the City-owned portion of substandard water services between Clouston Ave to Lippincott St. and from Sykes Avenue to Wright Avenue
- road resurfacing between Jane Street and Lawrence Avenue West

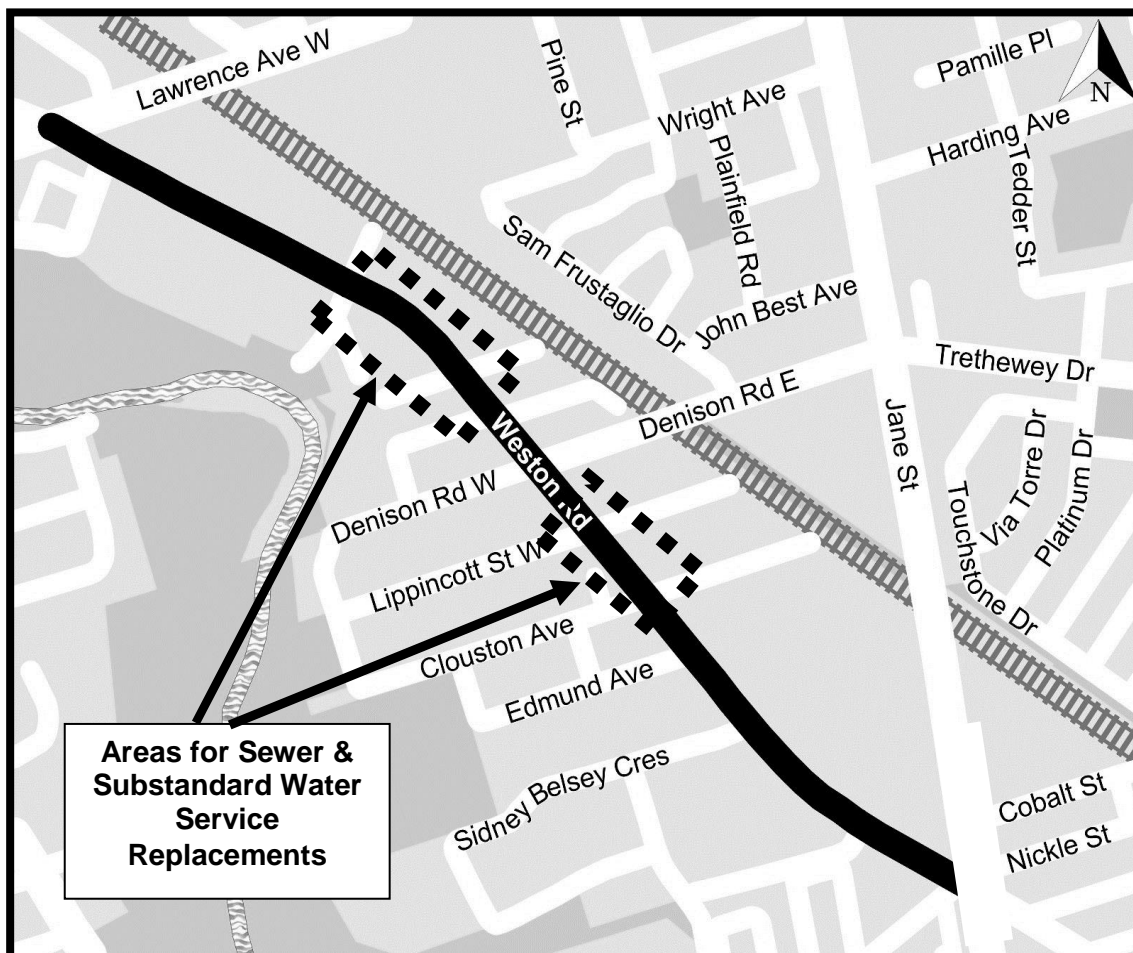
The storm sewer is an underground pipe designed to collect stormwater and melting snow and release it into a nearby creek or river. The water service is the underground pipe that brings water to your water meter and is owned by you and by the City. The part you own is from your house to the end of your property, the part the City owns is from the end of your property to the water main.

This project is part of the Council-approved 2017 Capital Works Program that will improve water distribution and the City's aging infrastructure.

IMPORTANT INFORMATION ABOUT LEAD WATER SERVICES

If you live on **Weston Road where the storm sewer is being replaced**, in a property that was built before the mid-1950s, your water service may be made of lead. Please read the attached fact sheet with important information about the risks of lead in drinking water, especially if someone in your house is pregnant, there are children under six years old, or there is an infant drinking formula made using tap water.

WORK DETAILS

The City's contractor will:

- Excavate the road and dig a trench to access and install the new sewer
- Replace any City-owned water service pipes that do not meet City standards from the water main to the private property line
- Repair curbs, gutters, sidewalk and driveways. Resurface the road

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and / or decorative objects. If you have a sprinkler system within the boulevard, please contact the Project Manager.
- The City will not be responsible for damage to any privately owned items on City property.

	<p>Work Hours: Work will take place from 7:00 am to 11:00 pm., Monday to Friday. There may be some weekend work, but it will not start earlier than 9:00 am.</p> <p>There may be weekend overnight work when crews are resurfacing the intersections at:</p> <ul style="list-style-type: none"> • Sidney Belsey Crescent • Clouston Avenue • Lippincott Street • Wilby Crescent <p>Further notice will be provided 48 hours before weekend work takes place.</p>
	<p>Water Service Disruptions: From time-to-time, the water supply to your property will be shut-off to complete construction; the contractor will provide at least 24-hour advance notice. Throughout the work, it is recommended that you temporarily disconnect any water treatment systems (i.e. softeners or filters), water-cooled air conditioners or similar plumbing fixtures. Automatic lawn sprinkler systems may also be affected, therefore, you may need to water manually. In the event you did not received advanced notice, an emergency water shut off could have been necessary.</p>
	<p>Substandard Water Service Replacement: Please take the time to read the attached fact sheet carefully as it contains important information on lead in drinking water and how to prepare for replacement. If you want to replace your part of the water service pipe, contact the City's contractor for one of your quotes.</p> <p>Water Service Replacement Contractor:</p> <p>Company/Contractor: Ground Breakers Contracting Ltd. 	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Some of these efforts include adding Local Access signs, revising traffic signal times. Road users should expect delays and increased traffic on nearby main and side streets.</p> <p>Traffic on Weston Road will be reduced to one lane in each direction.</p>
	<p>Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at 416-808-2222.</p>
	<p>TTC Service: This project may affect travel times on the 89 Weston Bus. Visit ttc.ca for accurate schedule information.</p>
	<p>Garbage & Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. Please ensure that you label your bins with your address.</p>
	<p>Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
