

The City of Toronto will reconstruct Bill Cameron Lane in two (2) phases. Phase 1 will be from Hepbourne Street to Dewson Street and Phase 2 will be from Dewson Street to College Street.

This project is part of the Council-approved 2016 Capital Works Program to renew aging city laneways for current and future needs.

WORK DETAILS

The City's contractor will move equipment on-site and prepare the work area before construction begins. Construction crews will then:

- Remove the existing asphalt and granular base and replace with new granular base and asphalt.
- Restore areas affected by construction.

WHAT TO EXPECT DURING CONSTRUCTION

- You will experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. Your patience is appreciated.
- Property owners should remove items located within City property limits (boulevard or front yard), such as landscaping and / or decorative objects.
- The City will not be responsible for damage to any privately owned items on City property.

	<p>Work Hours: Work will take place from 7:00 a.m. to 7:00 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.</p>
	<p>Parking: If your vehicle has been displaced you will be provided with a temporary parking permit. If you have not received one then please contact the contract administrator listed below. However, temporary parking permits for Phase 2 will not be delivered until the week of October 11, 2016.</p> <p>Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at 416-808-2222.</p> <p><i>In the event you receive a traffic ticket for on-street parking during this period of construction, please immediately contact Taras Pawluk (416-806-1763), so that your ticket can be cancelled.</i></p> <p>Please note that parking tickets cannot be cancelled if vehicles were parked in illegal parking spots such as in front of a fire hydrant or in no parking zones, or if they are submitted more than three days after receipt.</p>
	<p>Garbage & Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <i>Please ensure that you label your bins with your address.</i></p>
	<p>Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
